Dear Hydrographer,

1. In accordance with the General Regulations of the IHO (Reference A), Assembly Circular Letter No. 7 (Reference B) requested Member States to consider approving the lists of Observers¹, to be invited to attend the 4th Session of the IHO Assembly (A-4) and to provide further comments, if any, on the lists.
2. The IHO Secretariat thanks all 74 Member States that have replied to ACL07. Only seven Member States offered comments in addition to their vote and five Member States voted “No”. The comments and the outcome of their review by the IHO Secretariat are provided in Annex A to this letter.
3. There are currently 103 Member States of the IHO with two Member States suspended at the time ACL07 was issued. Therefore, in accordance with Reference A applicable when Reference B was issued, the minimum number of votes required is 68. As this requirement has been met, the lists of invited Observers are approved and, consequently, the invitations to attend A-4 will be issued.

**MEMBER STATES' RESPONSES TO ACL 7
AND COMMENTS FROM THE IHO SECRETARIAT**

Invited Observers to A-4

GEORGIA voted **NO**

"Georgia fully respects the technical and apolitical mandate of the International Hydrographic Organization, as defined in its Convention. Nevertheless, in line with Georgia's national interests and in full conformity with the positions of the Government of Georgia, including the Ministry of Foreign Affairs, as well as the requirements of Georgian legislation, Georgia is unable to support states that have recognized the autonomous republic of Abkhazia or so called South Ossetia as independent entities, including countries such as Nauru and Nicaragua. This position is based on the established norms of international recognition and reflects Georgia's consistent policy of preventing any action that may inadvertently lend legitimacy to entities created in violation of Georgia's sovereignty and domestic legislation. Georgia remains committed to constructive participation in the work of the IHO and values the Organization's technical mission, while upholding the fundamental principles that guide its foreign policy and international obligations. At the same time, Georgia welcomes the participation of any state in the General Assembly as an observer, provided that such participation is consistent with the principles of territorial integrity, sovereignty, and internationally recognized norms."

IRAN (ISLAMIC REPUBLIC OF) voted **NO**

Iran does not agree with inviting Israel as an Observer to A-4.
