- 1. As reported in Reference A, the 9th Meeting of the IHO Council (C-9) will be held at the IHO Secretariat in Monaco from Tuesday 14 to Thursday 16 October 2025 as a face-to-face event with passive live streaming.

- 3. This Council Circular Letter is also to remind you that, in accordance with Reference B (Rule 7 refers), the deadline for submitting proposals is **no later than 15 July 2025**. All documents received after the deadline will be considered as information papers only.
- 4. In order for the IHO Secretariat to prepare the C-9 *Red Book* and make it available on the C-9 IHO Portal page at least two months before the opening day of the meeting of the Council (in accordance with Reference B), Member States are invited to monitor the updates made on the list of proposals on the C-9 section of the IHO Portal on a regular basis and to forward any comments that they may have, so they reach the IHO Secretariat (by e-mail: cl-lc@iho.int, Word version in arial font preferable or converted pdf file) no later than 5 August 2025 ("...ten weeks before the opening...", in accordance with Reference C, paragraph 1).
- 5. To facilitate the preparation of the C-9 organization and based on the experience from previous Council meetings, Member States having a seat at the Council are also invited to nominate rapporteurs by email to: eric.langlois@iho.int, by 5 August 2025. Instructions for rapporteurs will be provided on request. For planning purposes, it should be noted that the rapporteur(s) in charge of Thursday session 5 may need to work with the IHO Secretariat until Friday afternoon (close of business), when the summary report/proceedings from the précis-writers for these two last sessions will be made available for review and validation.
